

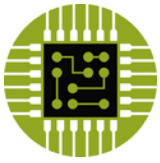


Agencies that require additional resources to complete Phase 1a readiness activities have the following options to request support:



### Agency Organizational Change Mgmt. Pool

One Washington staff assigned to eligible agencies, with One Washington oversight, to focus on OCM activities in Phase 1a such as **communications and learning**.



### One Washington Technology Pool

Provides funding to eligible agencies to **remediate approved legacy systems that will not be replaced** as part of the Workday Phase 1a implementation.



### 2022 Supplemental Budget Request

Eligible agencies with additional resource or technology needs for Phase 1b can submit a **supplemental budget request** to One Washington per the budget instructions released in June.

## Eligibility and How to Apply

Only **select agencies are eligible to apply** for the funding pools based on degree of impact and other factors. Likewise, specific agencies are eligible to apply for a supplemental budget request. If your agency is eligible for the pools or the supplemental budget request, your AST Lead will receive instructions on how to apply.
